***HIGHLIGHTS AS OF SEPTEMBER 30, 2018***

**MONEY RAISED AS OF SEPTEMBER 30, 2018 BY PRESIDENT JACQUELINE CALDWELL**

\$8,500.00 – Donations

**REVENUE FROM A PARTNERSHIP WITH HUNTS UNITED METHODIST CHURCH OF TOWSON**

This is the sixth year of a partnership with Hunts United Methodist Church of Towson to hire six to seven youth from the Frederick Douglass Senior High School to work as summer assistants at the William S. Baer School (located in the Greater Mondawmin community). GMCC has acted as the fiscal agent and we have received approximately \$70,000.00 to support this summer work-force initiative.

**PLANNED FUNDRAISING RAFFLE ORGANIZED BY PRESIDENT CALDWELL FOR OCTOBER 2018**

GMCC Book Give Away scheduled for November 2018 – funds raised will be used to buy books for youth featuring persons of color. The books will be distributed to the Free Little Libraries in the community – Center for Urban Families, Howard Peters Rawlings Conservatory and Botanical Gardens, and Garwyn Medical Center. A raffle is underway to support the purchase of these books.

**PLANNED END-OF-YEAR DIRECT SOLICITATIONS FUNDRAISER**

President Caldwell is planning an end-of-year “ask” of private donors. Funds raised will go towards general operating expenses.

### **PLANNED REVENUE FROM GRANT WRITING**

GMCC is in the process of developing and submitting four grants by December 15, 2018 to private foundations for operating costs (unrestricted grant funds). Revenue is expected of \$10,000, to be received in 2019.

### **PARTNERSHIP WITH TOUCHPOINT BALTIMORE AT MONDAWMIN**

GMCC is the community partner with TouchPoint Baltimore at Mondawmin – President Caldwell coordinates and creates activities into the space for the community. During the Summer of 2018, 100 youth attended drone workshops on Saturdays – each youth received a drone to take home. This was a \$13,000 investment in our young people regarding Science, Technology, Engineering, and Mathematics (STEM)-related programming. Baltimore School for the Arts, Art w/a Heart, Peabody Conservatory, and Notre Dame Prep are scheduled to have events in the community.

### **PARTNERSHIPS WITH NEIGHBORHOOD HOUSING SERVICES (NHS)**

GMCC partnered with Neighborhood Housing Services (NHS) to facilitate the Porch Project currently underway in the Mondawmin Neighborhood Improvement Community (an affiliate of GMCC). Nineteen houses are slated to be renovated with new porches, windows, and other beautification fixtures or items. NHS acted as the fiscal for GMCC on this \$250,000 project.

GMCC is the community partner with NHS on the Walbrook Lumber Yard Project on West North Avenue (which borders the GMCC community). This will be a mixed used development of affordable housing and retail establishments with a price tag of approximately \$20.2 million dollars (\$20,200,000.00). The project is underway and slated to be completed in 2019.

GMCC is the community partner with NHS – North Avenue Redevelopment – 19 stores are to receive grants for façade improvements on West North Avenue, below Hilton Street.

### **PRESIDENT JACQUELINE CALDWELL ELECTED CHAIR OF THE BOARD OF DIRECTORS FOR NEIGHBORHOOD HOUSING SERVICES**

President Caldwell was elected board chair of NHS in April 2018.

### **PARTNERSHIP WITH ENTERPRISE HOMES**

GMCC is the community partner with Enterprise Homes – Metro Heights affordable housing development has been completed – 70 affordable housing apartments and amenities - \$20.4 million dollars (\$20,400,000.00). The ground breaking will be held in September 2018. This project is in the Liberty Square community (an affiliate of GMCC).

### **PARTNERSHIP WITH ENTERPRISE HOMES, NEW SHILOH BAPTIST CHURCH, AND BON SECOURS HEALTH SYSTEM**

GMCC is the community partner with Enterprise Homes, New Shiloh Baptist Church, and Bon Secours Health Systems for the New Shiloh Family Apartments, 70 affordable housing apartments that opened September 2018. This \$22.7 million project features apartments which are Leadership in Energy and Environmental Design (LEED) certified, ensuring that the apartments were built with materials that are “green” or environmentally friendly.

## **PARTNERSHIP WITH STRATEGIC BOARD FOR INNOVATION WORKS**

As of August 2018, President Caldwell serves on the Strategic Board for Innovation Works, a Jesuit social enterprise concept, which encourages and support entrepreneurship.

## **ASSET MAP OF GMCC SERVICE AREA**

GMCC, together with Healthy Neighborhoods and Neighborhood Design Center, has created an asset map of our community – GMCC is changing the narrative from negative to positive.

## **WALKING TOURS**

GMCC conducted six walking site tours with TouchPoint Baltimore at Mondawmin partners – *The New Auchentoroly Terrace Association* (led to removal of dumping), *Mondawmin Neighborhood Improvement Association* (resulted in a Trash Can Pilot – to eradicate illegal dumping on the corner of Reisterstown Road and Gwynns Falls Parkway – platform built, new trash cans installed, and coordinated with Baltimore City officials and DPW to have trash picked up from this site), *Liberty Square* (resulted in City Councilman Leon Pinkett and his city officials to tour the neighborhood and address longstanding dumping issues), *Whittier Monroe Neighborhood Community Association* (resulted in walking tour of the community with City Councilman Leon Pinkett and his city officials); *Robert W. Coleman* (shared vacancy and vacant lot issues); and *Parkwood* (need representation). Walking tours to be scheduled with Fulton Heights, Parkway and Panway.

## **PARTNERSHIP WITH BAER SCHOOL**

GMCC is represented on the board of the William S. Baer School – this partnership has yielded interest from Southway Builders, which in 2018 constructed a structure in the indoor courtyard for the children.

## **STRENGTHENING PARTNERSHIP WITH PARKS AND PEOPLE FOUNDATION**

President Caldwell served on the Event Committee for our GMCC board member Parks and People Foundation’s annual fundraiser – Picnic in the Park.

## **MISS JACKIE READS TO CHILDREN AT THE FARMERS MARKET AT DRUID HILL PARK**

President Caldwell read to youth at the Farmers Market at Druid Hill Park this summer and gave away free books. President Caldwell represented GMCC on the Friends of the Conservatory board for 4 years.

## **LIGHT CITY**

In 2016 and 2017, GMCC participated in the Light City Initiative. Light City is an event hosted by the City of Baltimore to encourage the arts in communities and add to the positive narrative of communities. In April 2018, GMCC was selected as a 2018 Light City Pop Up site – “Where is Charlie?” Tim Williams of WJZ-TV Channel 13 interviewed the GMCC president; the interview showcased the GMCC community on both the 5 PM and 11 PM newscasts.

### **CHARM CITY TV INTERVIEW**

GMCC President Caldwell was interviewed by Charm City TV – Cable Channel 25. This interview highlights members of the GMCC community and our assets. This interview is still being shown on Channel 25.

### **MEETINGS/PANEL DISCUSSION**

In 2018, President Caldwell attended more than 50 meetings representing GMCC (including but not limited to: Civic Leadership Workshop: Inspiring Success Through Collaboration class given by Business Volunteers of Maryland – June 2018) and served on more than 10 panels (i.e. Panelist – Community Renaissance in Mondawmin for the Association of Community Design Conference – Motor House on East North Avenue) to discuss the Greater Mondawmin community and our assets.

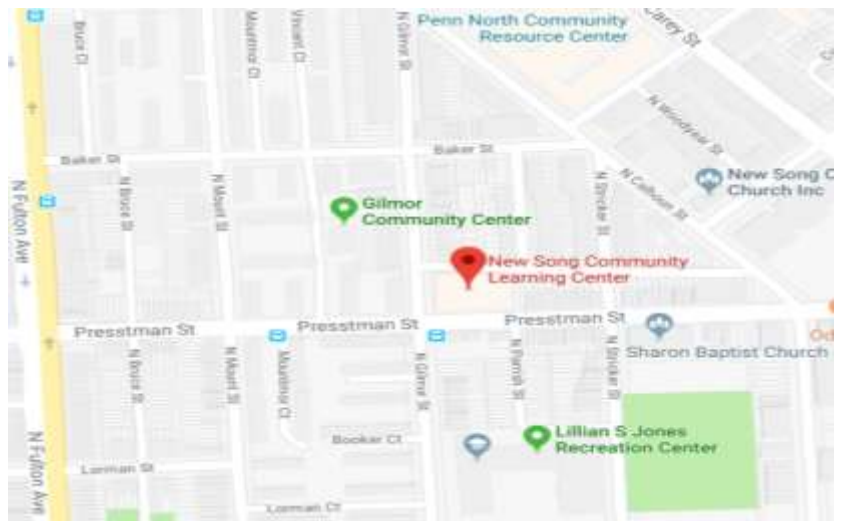

## THE NEW AUCHENTOROLY TERRACE ASSOCIATION, INC.

ATA's monthly meeting was held at Parks & People Foundation – The Stone House on Thursday November 8, 2018. Community member **Corrine Litchfield** opened the meeting and **Deacon Tally** led our opening prayer. The minutes from the October 11<sup>th</sup> meeting were read by secretary, **Anne Goncalves**, and approved as read.

**President, Barbara Anderson Dandy** welcomed residents and our partners ; Sandra Almond-Cooper, and Mario Chang

### Agenda:

**Dr. Daniel J Hindman**, a community member and doctor, recently received the Bloomberg American Health Initiative Health Equity Workgroup Seed Grant to study access to Druid Hill Park and health. Dr. Hindman discussed who he is, what Druid Hill Park has to do with health and what it looks like to study health in communities. Dr Hindman explained to residents how his questions about this topic developed discussed the effects of the park on the public health of the surrounding communities. In addition to discussing how the study will impact community members – a door to door survey in ATA and Reservoir Hill - Dr. Hindman shared his impact goals for the study: he wants community members input on how to do the survey; he wants it to benefit the community; he wants the community to know the results of the study; and he wants this study and our community's voice to inform Councilman Pinkett's efforts and the city's plans to change access to the park. A Q & A period followed in which residents were able to engage with Dr. Hindman about the study.

**Graham Coreil-Allen**, ATA's social media specialist and public artist received an Open Society Institute Baltimore Fellowship Project for 2018. Open Society Institute is a nonprofit which focuses on education, addiction, and public health. Funded by his grant from OSI Graham will be working on The Complete Streets project in our community for the next year and a half. Complete Streets aims to make streets safe for everyone including bikes, pedestrians, and cars. He wants to bring the meetings into everyone's lives, and he wants the city planners to be informed by the community members. He makes art focused on public safety and also leads walking tours, an interactive community advocacy and development tool. He and Councilman Pinkett developed the Druid Hill Park Stakeholder Group which advocates for groups around the park as the park is redeveloped and reorganized. His work on traffic calming through public art projects will be kicking in to full gear in December.

A representative from the **Western District Police Department Community Collaboration Unit, Officer Randolph**, greeted residents and gave them an update. The Mondawmin area is having a lot of larceny and burglary: please lock up valuables out of sight. Community members asked for information on a Crime Watch Camera on Ruskin and Parkwood. Residents were able to ask questions and voice concerns.

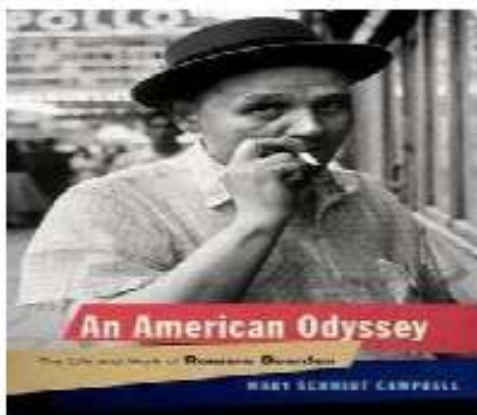

## An American Odyssey: The Life and Work of Romare Bearden

By the time of his death in 1988, Romare Bearden was most widely celebrated for his large-scale public murals and collages, which evoked the black experience in America. ### HOME IMPROVEMENT LOAN

For homes located within a "Healthy Neighborhood."

- Minimum loan amount is \$5000. Maximum loan amount is \$20,000. Maximum aggregate loan amount secured by the property shall not exceed 105% of after-renovation value, as established by an appraisal.
- Homeowners will make improvements to the property, including visible exterior improvements
- The free services of an architect are available to help homeowners plan improvements and to review contractors' proposals.
- No owner financial investment is required. **All recipients of a HN Loan maybe eligible to receive a \$10,000 matching rehab grant (income limits apply)**
- Construction terms will be six or 12 months. The maximum permanent term will be 10 years.
- The loan interest rate during rehab will be fixed on the date of application until home renovations and the construction term are complete, at which time the loan must be refinanced to permanent status at the current program loan rate.
- Borrowers will be underwritten and approved by M&T Bank. Borrowers' must meet Fannie Mae/Freddie Mac standard underwriting guidelines.
- Permanent interest rate will be Prime minus 1%, but in no event less than 4% .



#### Eligibility Requirements:

The borrower must be the owner-occupant of the property.

The borrower must not own any rental property

Housing expenses should not exceed 30% of the buyer's income and total debt should not exceed 40% of buyer's income

Borrower must have a minimum 700 credit score

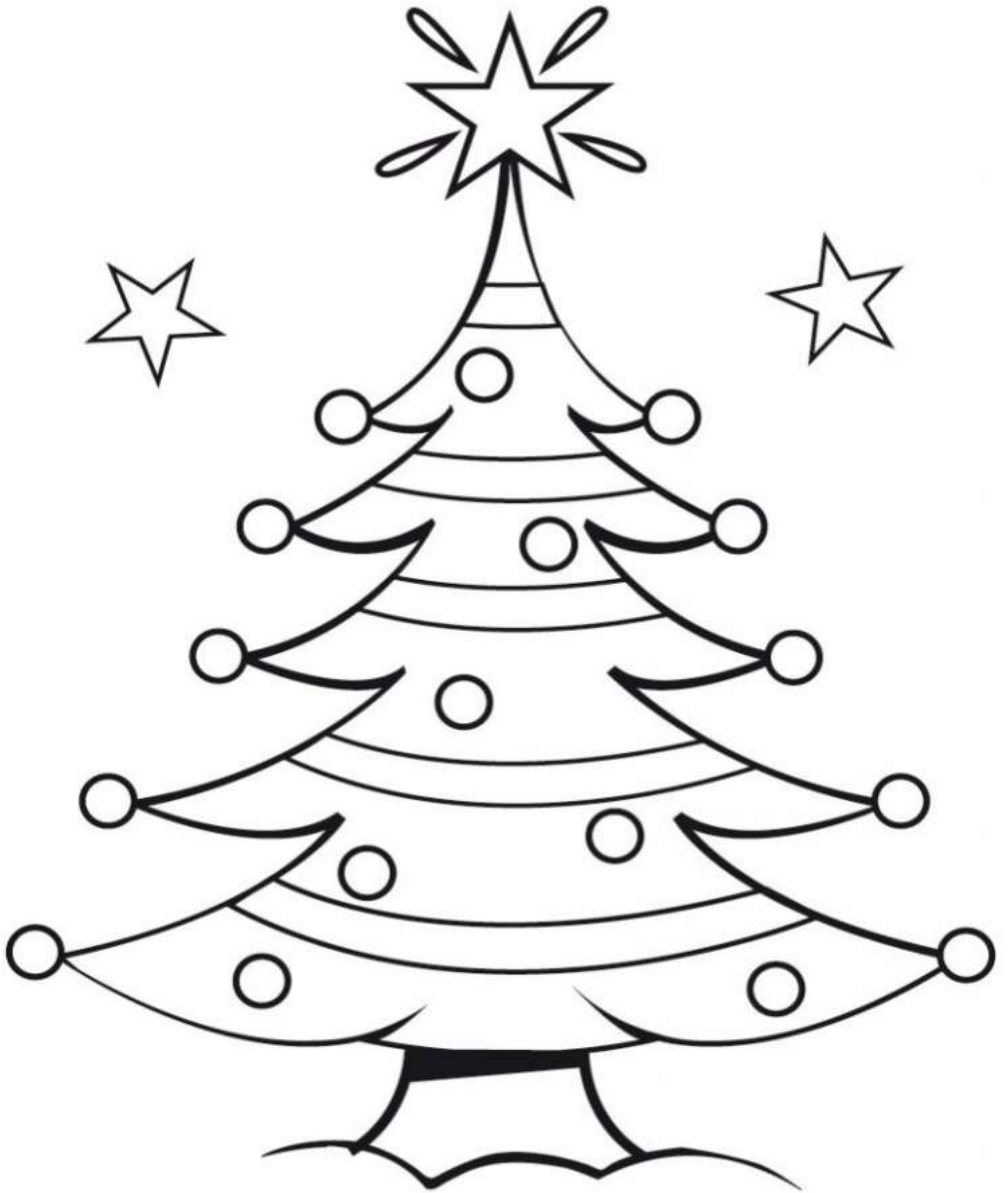
