If you would like to join our Partner Referral Challenge, please contact me. **Please see below for detailed descriptions of CFUF's programs as well as upcoming August 2019 start dates for *Baltimore Responsible Fatherhood Project (BRFP)* and *STRIVE* (see fliers attached):**

Baltimore Responsible Fatherhood Project (BRFP): The goal of the Baltimore Responsible Fatherhood Project is to assist fathers with the removal of barriers that may hinder them from being the best men and parents they can be. CFUF does this by offering support around areas such as child support assistance and management; understanding positive parenting skills; increasing healthy relationships and communication; and helping with job readiness and employability. BRFP meets on Monday, Tuesday, and Wednesday evenings from 5:30-8:30 pm for 4 weeks, and dinner is served during the sessions. In addition to the evening sessions, the program includes an opportunity to earn up to \$150 in performance-based incentives, father-based incentives, free father-child outings, case management, and more. BRFP is open to fathers, step-fathers, grandfathers, involved uncles, and other father figures who are ages 18+ who care for children 17 years old and younger. The next BRFP cohort begins Monday, August 5, 2019.

STRIVE (Support Training Results in Valuable Employees) is for adults ages 18-62. The STRIVE model emphasizes attitudinal training, job placement, and post-placement support. STRIVE prepares participants for the workforce through a strict, demanding training that focuses on sharpening job-seeking and job-readiness skills and improving workplace behavior, appearance, and attitude; cycles last 3 weeks during which participants meet from 9:00 am-5:00 pm, Monday through Friday. Upon completion of the training, STRIVE graduates receive assistance with job placement. A key component of STRIVE is that its graduates are monitored by *All In* case managers for a minimum of 3-5 years. The next STRIVE orientation takes place Friday, August 9, 2019.

We also have free GED classes in collaboration with Baltimore City Community College (BCCC). Classes take place at CFUF on Tuesday, Wednesday, and Thursday evenings from 5:00-8:00 pm. The next class cycle will begin in September 2019, date t/b/d. Interested individuals need to register in advance. They can go through the assessment and registration process at CFUF on dates t/b/d or register at BCCC's Harbor Campus anytime. **Please note that the assessment test can take up to four hours, so plan accordingly.**

How Does Combining a Vacation with a Foreign Business Trip Affect the Tax Deduction for Travel Expenses of a Self-Employed Individual?

Note: effect for years 2018 through 2025, the Tax Cuts and Jobs Act of 2017 suspended the **deduction of miscellaneous itemized expenses that must be reduced by 2% of the taxpayer's** adjusted gross income. Employee business expenses, including travel expenses, fall into this category. Therefore, this discussion only applies to self-employed individuals for year 2018-2025.

Taxpayers often will hire an individual or firm to provide services at the taxpayer's home. Because the IRS requires employers to withhold taxes for employees and issue them W-2s at the end of the year, the big question is whether or not that individual is a household employee.

Taxpayers are often confused by the differences in tax treatment between businesses that are entered into for profit and those that are not, commonly referred to as hobbies. Recent tax law changes have added to the confusion. The differences are:

What if you Want To File Your Taxes But Can't Afford to Pay Them?

It's a common conundrum: You want to file your taxes on time, but you anticipate or already know that you will owe money you can't afford to pay right now. As a result, you put off filing your tax return under the assumption that the IRS can only bill you if they receive your latest outstanding tax return that's due.
